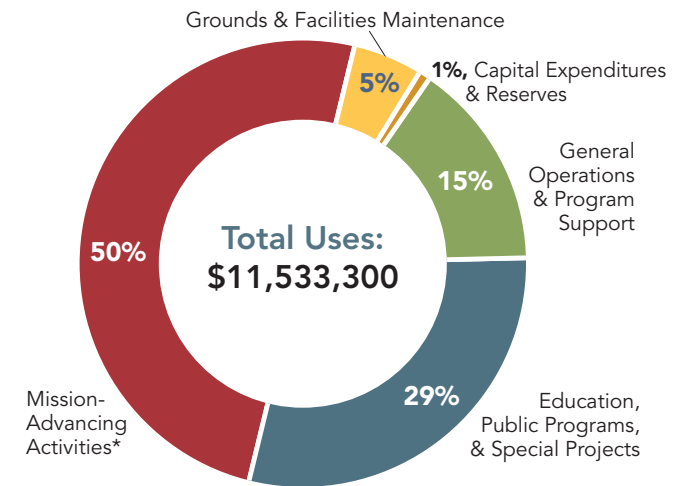
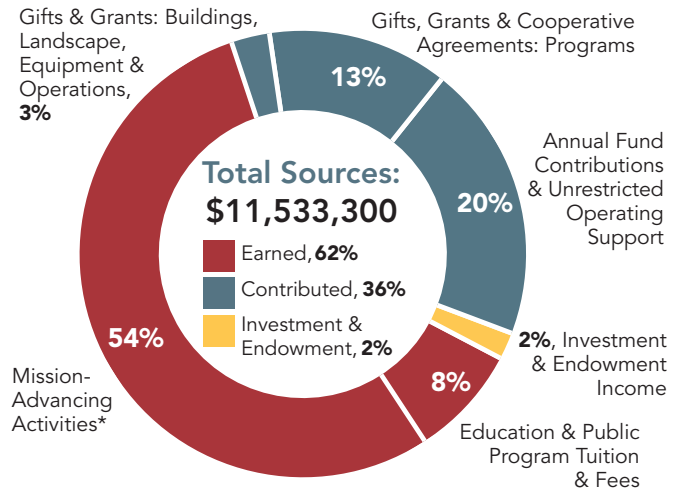

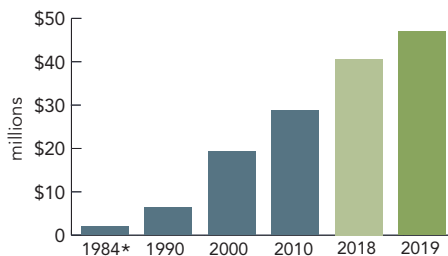
Consolidated Annual Operating Revenue & Expenditures**

Year Ending December 31, 2019

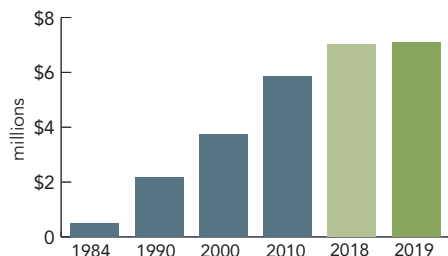

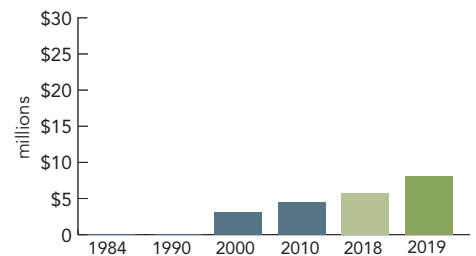
Total Assets

(Fees/Tuition/Services/Products)

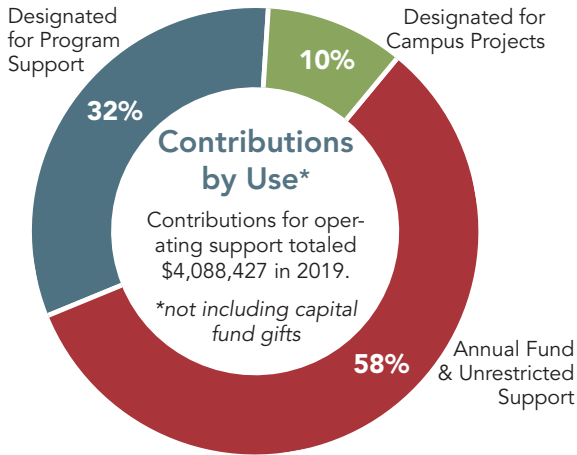


Board Designated and Restricted Endowment Funds

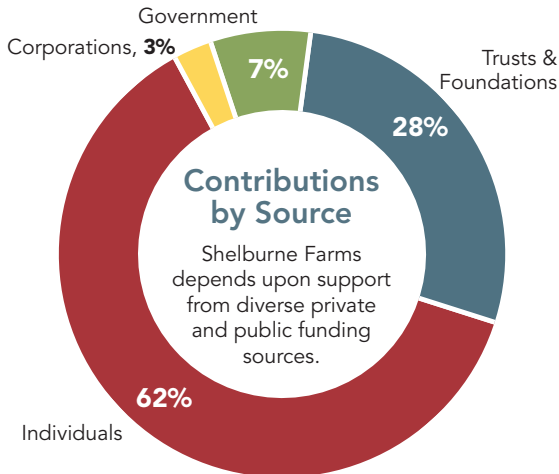
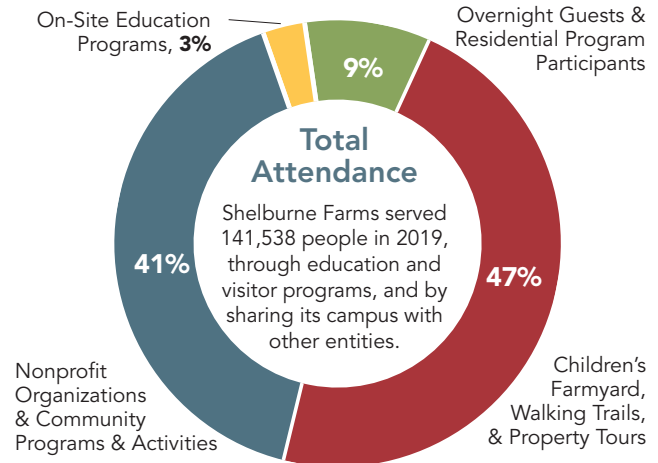

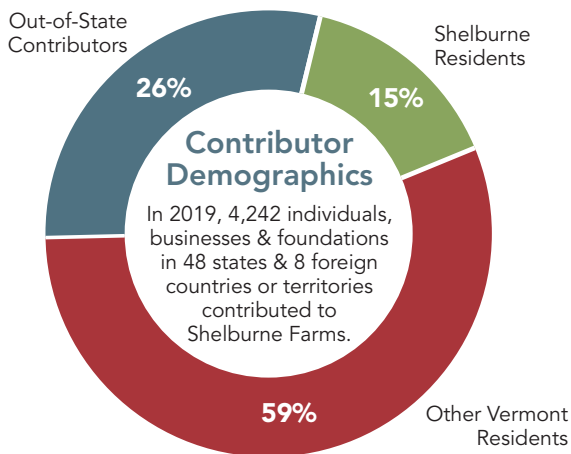
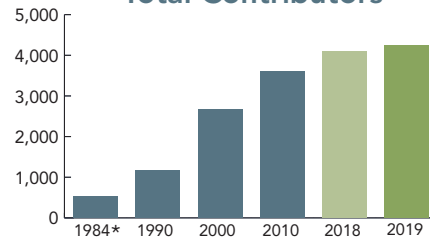
Annual Operating Support



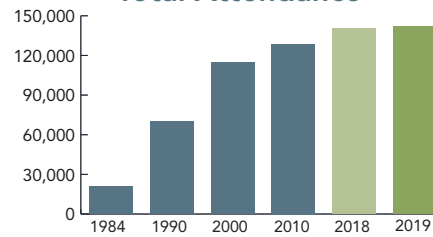
Program & Visitor Attendance



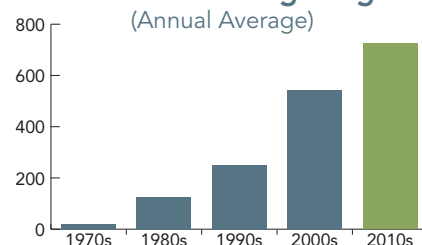
Total Contributors
